

MINUTES OF THE REGULAR MEETING OF COUNCIL OF THE VILLAGE OF KENASTON HELD ON TUESDAY, JUNE 10, 2014 IN THE VILLAGE MUNICIPAL OFFICE AT 700 FOURTH STREET IN THE VILLAGE OF KENASTON IN THE PROVINCE OF SASKATCHEWAN.

- Order Mayor, M.L. Whittles called the meeting to order at 7:00 p.m.
- 61/14 Blenkinsop: That the minutes of the regular meeting of council held on Tuesday, May 13 and special meeting held on Wednesday May 21, 2014 be approved as read. Carried.
- 62/14 Corres. a) Village lot behind Matzner’s – Complaint regarding useage
- 63/14 Menzies: That the correspondence having been presented be filed. Carried
- 64/14 Financial Blenkinsop: That the financial Statement and Bank Reconciliation for the month ended April, 2014 be approved as presented. Carried.
- 65/14 Financial Tomlenovich: That the financial Statement and Bank Reconciliation for the month ended May, 2014 be approved as presented. Carried.
- 66/14 Budget Menzies: That the council approve the 2014 budget as presented by the finance committee. Carried.
- 67/14 Accounts Whittles: That we ratify the accounts that were paid before this meeting by cheques numbered #9181 through #9200 listed on Appendix “A” totalling \$22,393.07 and that the submitted accounts listed in Appendix “A” totalling \$19,108.35 be approved for payment with cheques numbered #9201 through #9210.
