

BYLAW NO. 1/24

A BYLAW OF THE VILLAGE OF KENASTON TO FIX THE RATES  
TO BE CHARGED FOR THE USE AND CONSUMPTION OF  
WATER AND TO FIX THE RATES TO BE CHARGED BY WAY OF  
RENT OR SERVICE CHARGE FOR THE USE OF SEWER

COUNCIL of the Village of Kenaston, in the Province  
of Saskatchewan, enacts as follows:

1. The charges to be paid by the water consumer whose water service has been turned on shall be those set out in Schedule "A" attached; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.
2. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "B" attached.
3. Accounts for water service and/or sewer service shall cover a period of three successive months, unless otherwise specified on Schedule "A" and Schedule "B", and shall be rendered on or before the first day of the month next following such period. Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered. If an account is not paid within the period of thirty days, the water service may be cut off. When the water service is cut off, it shall not be turned on until all arrears have been paid, together with a fee of **\$50.00 for disconnection** to cover the expenses of turning off the water and turning it on again; provided that if it is required to turn on the water service outside the employees' regular working hours, the fee shall be **\$100.00 for reconnection**.
4. Bylaws No. 2/19 is repealed.

THE rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee.

**SCHEDULE "A"**  
**TO BYLAW NO. 1/24**

**QUARTERLY WATER RATES:**

The quarterly charges to be paid by the resident and commercial water consumer whose water service has been turned on shall be:

\$ 162.00 water consumption up to 60 cubic meters and \$0.30 per cubic metre in excess of 60 cubic meters or any prorated portion thereof for 2024 & 2025.

\$ 174.00 water consumption up to 60 cubic meters and \$0.30 per cubic metre in excess of 60 cubic meters or any prorated portion thereof for 2026 and forward.

The quarterly charges to be paid by the community churches and Seniors Centre whose water service has been turned on shall be:

\$ 81.00 water consumption up to 60 cubic meters and \$0.30 per cubic metre in excess of 60 cubic meters or any prorated portion thereof for 2024 & 2025.

\$ 87.00 water consumption up to 60 cubic meters and \$0.30 per cubic metre in excess of 60 cubic meters or any prorated portion thereof for 2026 and forward.
